

# Privacy and Cookie Statement Prowise

Welcome to our website! The protection of your personal data and privacy is very important to us. Below we will explain which data we process when, for which purpose and on what legal basis. It will be explained how our offered services work and how the protection of your personal data is guaranteed.

Based on Article 4(1) of the General Data Protection Regulation (“**GDPR**”), personal data means any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly.

### 3. Log files

If you open our website, we automatically register data from your device, part of which we store in server log files. The data is automatically transmitted by your browser as soon as you open our website. At this time, the following data is registered:

- time on which our website was accessed (request to the server of the host provider)
- URL of the website from which you have accessed our website
- the operating system you are using
- type and version of the browser you are using
- your IP address

By processing this data, we aim to improve the accessibility of our website from your device and enable a correct display of our website on your device or in your browser. In addition, the data helps us to optimize our website and improve the security of our systems. In addition, our system has to process your IP address to enable our website to be delivered to your device. This data is not used for marketing purposes.

Article 6(1) sentence 1 under f) GDPR constitutes the legal basis for the processing. We have a legitimate interest in presenting you with a website that has been optimized for your browser and enabling communication between our server and your terminal device. For the latter it is particularly necessary to process your IP address.

We store the data for 14 days.

### 4. Cookies

Our website uses cookies. Cookies are text files that are stored on your device, for example to make it easier to use a website or to recognize the user's device and save settings etc. Cookies can store input data and settings for a website so that these do not have to be entered again each time you visit a website. Cookies contain a "cookie ID", which makes it possible to assign it to the device on which the cookie was stored. We use the following cookies for this purpose:

- Cookies that contain a randomly generated, specific identification number that allows our website to identify you or your device during your visit. These cookies are automatically deleted at the end of your visit.
- Cookies that contain a randomly generated, specific identification number that allows our website to identify you or your device. The legal basis for the processing of personal data described here is Article 6(1)(f) GDPR. Our required legitimate interest in this respect lies in the overall usefulness YouTube offers. The integration of external videos relieves our server and allows us to use the saved resources differently. This can, among other things, increase the stability of our server. Furthermore, YouTube and Google have a legitimate interest in the collected data and personal data to improve their own services.

The libraries are integrated with jQuery via an interface (API). Through the integration of the libraries, JS Foundation may collect data, including personal data, and process it.

JS Foundation indicates that the following data, including personal data, may be processed:

- visits/accessing of pages
- duration of visits/accessing of pages
- landing and exit pages
- location
- IP address
- browser technology.

In addition, jQuery Foundation indicates that this data may also be shared with third parties.

Because of the possibility of a uniform display, the design costs are lower than if we would have had to respond to different fonts from different operating systems and browsers with our own graphically modified websites.

## 12. Presenter account

You can create a user account on our website for our Presenter web application.

In the context of registering for an account, the data entered in the input fields will be processed by us. This includes the following data:

- emailadres
- first name
- surname prefix
- surname
- language/country
- type of user
- password

The data is required to create a user account for you.

When the registration is transmitted, the following data are also processed:

- your IP-adres
- date and time of transmission

The registration takes place according to the double-opt-in procedure. After registration, you will receive an activation link at the e-mail address provided by you, which you must confirm and/or activate. In this way we check whether the email address entered on our website is actually yours. If the confirmation or activation link is not used within 48 hours, the registration will no longer be performed and the confirmation or activation link will expire. In that case you have to perform the registration procedure again. If an email address is not confirmed within the time frame mentioned above, we will delete the registration data.

If you click on the activation link, we will process the following data as part of the double-opt-in:

- your IP-adres
- date and time of transmission

We process the personal data in order to provide the user with their own user account. The purpose of processing the double-opt-in data is to prevent misuse of the registration.

The legal basis for the processing of personal data described here is Article 6(1)(f) GDPR. We have a legitimate interest in providing you with a user account and thus giving you the opportunity to make full use of our Presenter web application. We have an interest in processing the double-opt-in data to prevent misuse.

**Right to object**

**You have the right to object.** You can deactivate and/or delete your user account yourself at any time.

You can also send or notify us of your objection at any time (for example via an email to [privacy@prowise.com](mailto:privacy@prowise.com)).

The processed data will only be stored for as long as is necessary for the intended purpose or as required by law.

The provision of personal data is neither legally nor contractually required nor necessary for the conclusion of an agreement. You are not obliged to provide personal data either. However, without the required data we cannot create a user account for you and give you access to our web application.

### 13. Form to request forgotten password

Our website contains a form by means of which you can request a forgotten password. If you contact us using this form, the e-mail address entered in the input field will be processed by us.

When the request is transmitted, the following data will also be stored:

- your IP address
- date and time of transmission

We process the personal data in order to process your request regarding the forgotten password and contact you in connection with answering your request. The other personal data processed during transmission (IP address, date and time of transmission) are intended to prevent misuse of this functionality.

The legal basis for the processing of personal data described here is Article 6(1)(f) GDPR. We have a legitimate interest in giving you the opportunity to contact us at any time so that we can send you a new password.

The personal data will only be processed for as long as is necessary for offering the functionality.

The additional personal data collected during the transmission of the form to request a forgotten password will be deleted after 52 days at the latest.

### 14. Contact Form

Our website contains contact forms that can be used to contact us digitally. If you contact us using this form, the data entered in the input field will be processed by us.

When the message is transmitted, the following data will also be stored:

- your IP address
- date and time of transmission

Please note that the scope of the personal data collected in the context of the contact form also depends on which data you provide in the message body in the contact form.

We process the personal data in the context of both obligatory and optional data in order to process your contact request and contact you in connection with answering your request. The other personal data processed during transmission (IP address, date and time of transmission) are intended to prevent misuse of the contact form.

The legal basis for the processing of personal data described here is Article 6(1)(f) GDPR. We have a legitimate interest in giving you the opportunity to contact us at any time so that we can answer your requests.

The personal data will only be processed for as long as is necessary for offering the functionality.

The additional personal data collected during the transmission of the contact form will be deleted after 52 days at the latest.

## 16. Cloudflare

Our website uses the service Cloudflare. Cloudflare is a service of Cloudflare, Inc., +1 (650) 319-8930, 101 Townsend St, San Francisco, CA 94107, USA, which also provides this service.

Cloudflare offers a Content Delivery Network that protects our website against attacks on our server. This means that before your data ends up on our website, it is first transferred to a network of different servers (data centres) of the Cloudflare service. In addition, the data from our website and the data you send to us are also transferred to various data centres of the Cloudflare network.

The server of the Cloudflare network thus serves as an intermediate buffer, as it were, which enables data to be transferred to the Cloudflare network.

For this purpose, the data is sent to different servers in different locations.

In this context, it is likely that Cloudflare will also send the data to a server in a third country that is not a member of the EU.

The data sent to the Cloudflare network will be stored for 4 hours, after which the data will be deleted.

By processing the personal data, we aim to increase the reliability and access speed of our website, improve security, prevent attacks on our website or detect attacks early and thus improve the overall use of the website.

The legal basis for the processing of personal data described here is Article 6(1)(f) GDPR. Our required legitimate interest in this respect lies in improving the quality of our services and the security of our website, as well as to guarantee its fast and reliable use. Furthermore, we have a legitimate interest in guaranteeing the stability of our servers and to be able to compensate for fluctuations in capacity.

Our website uses the service Azure CDN. Azure CDN is a service of Microsoft Corporation, One Microsoft Way, Redmond, Washington 98052, USA.

Azure CDN offers a Content Delivery Network that protects our website against attacks on our server. This means that before your data ends up on our website, it is first transferred to a network of different servers (data centres) of the Azure CDN service. In addition, the data from our website and the data you send to us are also transferred to various data centres of the Azure CDN network.

The server of the Azure CDN network thus serves as an intermediate buffer, as it were, which enables data to be transferred to the Azure CDN network.

Please note that we analyse your usage behaviour when we send out the newsletter. We can register whether the newsletter sent is opened. The links in the newsletters contain UTM parameters.

UTM parameters enable campaign-specific tracking in Google Analytics. For you, this means that when you click on a link with UTM parameters, this click is registered in Google Analytics. In this way we can track how you respond to our individual newsletters (e.g. whether you have opened the newsletter), how many users have accessed our website via certain links and, for example, whether they have clicked on an image or text link in a newsletter before.

We use the following UTM parameters:

- medium: This parameter describes the medium in which the link is embedded. Examples: e-mail, social media or website
- source: With these UTM parameters we define the source of the link. These can be newsletters, websites, apps or social media channels.
- campaign: This type of UTM parameters indicates the actual campaigns. For example, if we send a newsletter to you every month, the individual newsletters can be analysed separately.
- term: Keywords to better identify the link
- content: In a campaign, we insert different elements to be tracked in order to unambiguously identify them and analyse them separately. Examples: button, image or video

The data will only be collected in pseudonymized form.

In the context of newsletter subscription, you consent to the processing of your personal data (Article 6(1)(a) GDPR), in which context we verify the subscription by means of a double-opt-in procedure.

In a first step, you enter the required data (e.g. e-mail address) and consent to the processing of your personal data by ticking the relevant box. In a second step, you will then automatically receive an email with a confirmation or activation link which you have to confirm or activate. In this way we check whether the email address entered on our website is actually yours.

We collect and process the user's email address in order to send the user a newsletter. The legal basis for the processing of the other personal data is our legitimate interest in accordance with Article 6(1)(f) GDPR. We have a legitimate interest in being able to demonstrate the consent given by you. In addition, we have a legitimate interest in preventing or demonstrating misuse of our newsletter.

## Right of withdrawal

### Right of withdrawal

**You have the right to withdraw your consent at any time without this affecting the lawfulness of the processing that took place on the basis of the consent given until the moment withdrawal.** You can send the withdrawal of your consent or notify us of the withdrawal of your consent at any time (for example
